President's Message

The SMHPS was recently given several acquisitions for the Richardson's House. We would like to express our appreciation to David Kirkpatrick and Patricia De Vault for thinking of us. Thanks to both of you for your generosity.

David Kirkpatrick long time owner of Hartman's Pharmacy donated six apothecary jars dating from the early 1900's. Hartman's was located at 26 N. Baldwin and was established in 1910 by W. E. Bechtelmeimer and purchased by Franklin H. Hartman in 1911. A year later it was moved across the street to 29 N. Baldwin. Mr. Hartman came to California on a visit and was impressed by the climate. He moved his family to Sierra Madre and started his pharmacy. Mr. Hartman's son Rudolph served an apprenticeship in his father's store and, in 1916, Rudy graduated from the USC School of Pharmacy and his name was added to the awning outside and the store was officially named "F.H. Hartman & Son, Drugs".

At the time of his father's retirement in 1937, he took over the pharmacy and was active in the business until 1977. Rudy sold the drug store to his competitor in early 1980 and they later sold out to Best Buy Drugs which is still located at 29 N. Baldwin.

An antique steamer trunk and a cast iron stove were donated by Mrs. Patricia De Vault from the estate of Kurt Gunther, M.D., a longtime resident of Sierra Madre. Mrs. De Vault is Dr. Gunther's daughter. Dr. Gunther was born in Koblentz, Germany on September 29, 1913, but lived in Hamburg, Germany where he received his degree to practice Internal Medicine. During World War II, he had to serve in the German Army as a doctor in the Luftwaffe. His personal loyalties were directed to U.S. allies, helping to get medical supplies to the Dutch underground, as well as making sure the key members of the Dutch underground didn't get sent to the German work camps.

After the war, Dr. Gunther came to live in the United States with the help of his British friends. He married Patricia Webb in 1950, lived in Santa Barbara, and practiced medicine at the Cottage Hospital. Dr. Gunther and his family moved to Arcadia in 1951, and then to Sierra Madre in 1977. He practiced medicine in El Monte serving the Greater El Monte Community Hospital, the Greater San Gabriel Community Hospital, and the Las Encinas Mental Hospital.

After the death of his first wife in 1965, Dr. Gunther re-married and his second wife purchased the trunk as an addition to her antique collection. The cast iron stove comes from a home purchased by Dr. Gunther in Vista, CA.
